Auditions will start at 10:15 AM, Sunday May 20th, 2018

- 1) This contest is open to all ages.
- 2) Contestants must provide their own karaoke CD & lyrics. The song must be ONE VERSE (max length is 2 minutes 30 seconds with NO EDITS). KZOO will fade out the song after the allocated time.
- 3) Entry fee will be a \$30 non-refundable fee payable to KZOO International Inc., P.O. Box 61671, Honolulu, HI 96839.
- 4) The preliminary round will begin at 10:15 AM on SUNDAY, MAY 20th, 2018 at the Japanese Cultural Center Ohana Room
- 5) Parking will be available street-side in the back of the Japanese Cultural Center (Coynoe St.) or inside the Japanese Culture Center for \$6 with validation (Validation will be provided for all contestants using the Japanese Cultural Center parking lot)
- 6) The GoGo KZOO International Karaoke Festival Finals will be held at the Sheraton Waikiki Hotel Hawaii Ballroom on Sunday, October 28, 2018 from 9 AM.
- 7) By signing this form, I acknowledge that the roundtrip airfare to Japan will only be awarded to the Grand Champion for competing in the NAK Grand Prix Contest in May 2019.
- 8) The deadline to bring both the application form and payment is MAY 15th, 2018. After May 15th, if BOTH the application form and/or payment are not turned/mailed in to KZOO by that day, the preliminary day entry fee will become \$60. Mailed applications and/or payment must be postmarked either before or on the day of MAY 15th, otherwise they will be considered late.
